  - a notice in a widely distributed national newspaper on June 10 and
    14, 2020 indicating that the documents can be found on the said website.
- 3. On the Applicant's attorneys-at-law's undertaking to file the Fixed Date Claim Form within 1 day from the hearing of this application, the first hearing of the Fixed Date Claim Form is fixed for June 24, 2020 at 2:00 p.m. for two hours.
- 4. Service of the Fixed Date Claim Form, the Affidavit in Support of the Fixed Date Claim Form and this Order is to be effected on the Attorney General and the Financial Services Commission.
